# 102/14 Update from Safer Neighbourhoods Policing Team

PCSO May said there were 22 reported incidents in February, including Anti-Social Behaviour, shoplifting. theft and criminal damage to cars on Cliff path. Beat officers would be changing, with the community team working out of Ventnor in future.

# **103/14 Planning Applications**

To resolve comments on planning applications received

**P00219/15** Spithead Business Park Partial demolition and erection of new food

Whitecross Lane store with parking/landscaping

**resolved** to support the application, however there are several matters that need to be secured by agreement between the Planning Authority and the applicant or by conditions attached to any grant of the application, and by planning contributions to highway projects.

- 1. The site occupies area previously used by traders and customers at Spithead Business Park for car parking, and its removal is already encouraging parking off site. This needs to be controlled by parking restrictions on both sides of Whitecross Lane from the Newport Rd roundabout to the entrance to the site, and also further into Merrie Gardens.
- 2. Access to the site for wheelchair users is poor, particularly for those arriving on public transport. An access ramp for wheelchair users and others needs to be constructed from the Newport Rd bus stop into the site. Dropped kerbs around the site (including proposed new pavements) to be reviewed and installed as necessary.
- 3. No deliveries to take place 22.30-06.30. Lighting in car park and on signs to be switched off between these times.
- 4. Whitecross Lane needs to be widened at the junctions of Merrie Gardens and the site access road so that a turning refuge can be created for traffic coming to the site from the north. The risk of accidents could be reduced by banning right turns out of the site access road into Whitecross Lane.
- 5. Whitecross Lane approach to the Newport Rd roundabout needs to be marked so that there are distinct left turn and right turn lanes, reducing the queuing of approaching traffic
- 6. A bus layby needs to be created at the Newport Rd westbound stop to prevent standing buses blocking other traffic.
- 7. Further developer contribution should be sought to secure finance for the long-standing project for a northbound bus layby in Sandown Rd, Lake, just north of the traffic lights, to reduce queuing that in the summer goes back up Newport Rd towards the site.
