# 26/14 Councillors reports

### (i) County Councillors

Cllr Hollands outlined the ongoing saga of the Cliff Path fence, and also problem with dropped kerbs in Sandown Rd following the recent resurfacing.

#### (ii) Parish Councillors

Cllr White said the charity event in aid of Sandown & Lake Youth Football Club had raised over £300. Defribrillators to be on agenda for next meeting. He referred to the state of New Rd toilets (Clerk's note: Mansells notified).

Cllr Horton said the IW Council litter bin at the top of Lake slipway needed replacement. The station garden was disgracefully overgrown.

Cllr Stephens urged that the traffic light phasing at Sandown Rd/Newport Rd be sorted out. Cllr Hollands said he had contacted Island Roads about this several times. He also referred to the tree removal by the war memorial.

Cllr D. Hardy said the Aldi planning approval condition regarding bus stops was believed to cover only the little used stops in Whitecross Lane. He said he had spoken to Mr Johnson at IW Council regarding a Community Asset Transfer in respect of the New Rd toilets site, which appeared feasible. The first stage would be consultation with local people through the medium of Ripples (18).
